Mike is a four-time Olympic medalist with the USA Men's wheelchair basketball team. I learned that people make mistakes every day, and forgiving is a great testament to your character.

Walking into the Holocaust Museum, I had one question. "Why? Why would the Nazis do this?" Hitler ranked people in society by race, religion, working ability, political dissidents, etc. Six million people were killed in the Holocaust. Jews were the primary victims. In the muse-

## A Message from Your Manager

### 2014 Rates

Recently we have been informed that our wholesale power provider, the Bonneville Power Administration (BPA), will be increasing our wholesale rates by an estimated average of 9 percent effective October 1. By the time you read this, we should have the actual figures of the increase. We will immediately update our Cost of Service Study (COSS) to determine the overall impact of these higher rates and present that study to the board for consideration. They have the task of approving all retail rates, and will use the sound judgment you have become accustomed to in establishing the retail rates for the upcoming year. Originally the BPA rate proposal included an increase of an average of 19 percent, but with the help of our alliances the increase sits at 9 percent as referenced above.

Speaking of our alliances, we currently belong to and support several entities that represent our interests and advise us on various issues at the federal and state levels, in addition to BPA. They include the National Rural Electric Cooperative Association, Montana Electric Cooperatives' Association, Western Montana Generation and Transmission (G&T), Northwest Requirements Utilities (NRU) and Northwest River Partners, Public Power Council and Northwest Public Power Association.

My point is that it takes a significant amount of effort to attempt to match the lobbying efforts of entities not aligned with our kind of thinking related to issues paramount to us, and primarily because of BPA's delivery

of wholesale power. The board and I review the costs versus benefits of belonging to these organizations routinely and only belong to those that provide adequate support of our causes. In the past, all of the alliances we share in have proven extremely beneficial, and as the old saying goes, "strength is in numbers." Without all of us joining hands, we would not be nearly as successful.

### Projects

This spring and summer our crews have been busy with budgeted projects to ensure the electric system remains reliable. Some of the work completed involved a total rebuild of a section of line on Carrigan Lane south of Dillon, completion of a three-phase replacement project southwest of Melrose, and replacement of an overhead single-phase line with underground on Lump Gulch Road west of Clancy. This is in addition to new and replaced services for new homes and irrigation pumps. These projects take a complete team effort, from the inside staff through engineering and, finally, actual construction — all completed entirely by Vigilante staff. I am very pleased with the coordination and effort put forth by your staff.

One project that we have contracted out is the pole replacement project in the Centennial Valley. These pole replacements are the result of pole testing we completed in that area last year. We have contracted with Western Line Builders to replace the "bad" single-phase poles in this area. Our linemen cannot replace the amount of poles needed this distance from the shop in an economical manner.

Recently, we completed another round of pole testing in the Wise River area. We

contract with Independent Inspection Services to test approximately 2,700 poles annually. This has proven to be an effective way to determine the integrity of the poles, and allow us to proactively replace these poles prior to failure.

The United States Holocaust Museum inspired me to confront hatred, prevent geno-

cide and promote human dignity.

Dana Falkenberg was a 3-year-old on American Airlines Flight 77 when it crashed into the Pentagon on September 11, 2001. The Pentagon Memorial honors the 184 men, women and children whose lives were lost, and their families. The memorial consists of illuminated benches arranged according to the victim's age. Each bench is engraved with the name of the victim. I paid respects to the brave, innocent victims and fam-

lies of the 9/11 attacks.

The Youth Tour was the greatest experience of my life. I learned life lessons, American history and how to give back to my community. I hope everyone can see our nation's capital and history like I did. On the tour I made life-long friends and memories that I will never forget. # Energy Efficiency Program Offering Manufactured Homes

In rural settings, manufactured housing is quite common and an option worth considering. Manufactured homes come in an array of modern floor plans, they can be customized for your personal tastes, they cost less than site-built homes, and they take less time to build because they are factory built. However, there is the perception that they are less energy efficient. This is something that the Northwest Energy Efficient Manufactured Housing (NEEM) program is trying to change.

The NEEM program, as part of Northwest Energy Works, is the longest-running residential energy efficiency program of its kind in the nation. Beginning in 1988, this organization has certified more than 200,000 manufactured homes, and the most ENERGY STAR homes in the country. Northwest Energy Works has been an integral part of the design, implementation and program management of this heralded program since its inception.

There are several reasons to look at NEEM rated Energy Star homes. First and foremost is quality construction. NEEM homes come with insulation packages that typically have R-values of 38 in the ceiling, 21 in the walls and 33 in the floor. The windows used have low-e glass. They also use quality components to ensure good indoor air quality and ventilation. Plus, NEEM rated homes use advanced duct-sealing techniques to reduce conditioned air loss.

NEEM rated homes are not only built to provide years of comfort, they also are designed to endure the travel from the factory to your

home site. Also, when you purchase a NEEM rated manufactured home, you will receive instructions on preparing the foundation, properly sealing the seam between the foundation and home, and sealing any cross connections in the ductwork.

What assurances are there? NEEM rated, Energy Star manufactured homes are inspected to ensure that insulation is properly installed, that energy-efficient windows and doors are installed, and that potential leaks are sealed.

Yes, NEEM homes initially cost a little more, but there is more to this than just the sticker price. In an article about NEEM rated manufactured homes, the Montana Department of Environment Quality addresses the long-term affordability of this purchase. It notes that the addi-

tional upfront cost is typically \$8 to \$10 per month over the life of the loan (approximately \$3,000 on a 30-year loan). However, it is estimated that you will save 30 percent on your annual heating bill, and improve summer comfort by reducing solar heat gain by 70 percent.

NEEM rated manufactured homes also are eligible for tax credits from the government, and an incentive from Vigilante Electric Cooperative on qualifying installations.

Vigilante Electric will offer an incentive of \$1,450 on a qualified installation of a NEEM rated Energy Star manufactured home. The home must receive its electricity from Vigilante Electric Cooperative; it must be new; electrically heated; and be designed, constructed and certified by the Northwest

Energy Efficient Manufactured Homes program as Energy Star. Application must be made and copies of all relevant documentation regarding this purchase must be provided. A Vigilante Electric employee will verify the location and NEEM certification prior to the incentive being paid.

This is just another example of the energy efficiency incentives that we make available to our membership. While the incentives we offer, combined with the eligible tax credits, may not cover the entire additional costs of upgrading to a more efficient home, the long-term energy savings and comfort will make it worth the investment. We would like to welcome Chase to Vigilante Electric; we look forward to a long relationship.

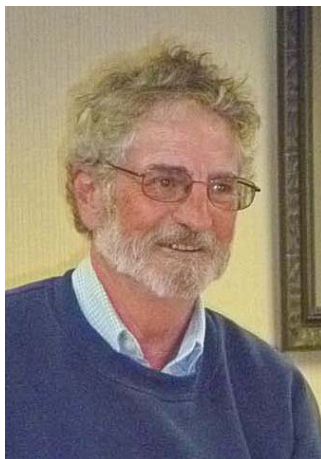


## Off The Clock — Bill Walker Retires
