

Distributed Generation

How things are changing

Our mission has been and always will be providing the highest quality of service at the lowest possible cost. This requires our Board of Trustees and management team to stay current on issues that could impact rates. In an industry such as ours, issues tend to evolve quickly and can be politically charged. Nowhere is this more evident than with distributed generation.

Distributed generation (DG) refers to power generation at the point of consumption rather than centrally located. It is a fuel displacer. At Vigilante Electric Cooperative, members can enter into an interconnection agreement to install DG on their side of the meter to reduce the need for electricity from the utility.

In 2002, Vigilante Electric established interconnection and net-metering guidelines and agreements. The interconnection agreement establishes the rights and responsibilities for connecting DG to the distribution system. The net-metering agreement is the explanation and acknowledgement for the billing side.

We allow installation of DG on residential services up to 10 kilowatts. Once the interconnection requirements are met, the member can offset part or all of his or her energy usage. At Vigilante Electric, true up is monthly. When a member puts more energy on the system than he or she takes off, the excess cannot be banked to use in another month.

About a year ago, we reviewed the economics of installing a 1 kW fixed-rack photovoltaic solar power system in our service territory. Today, much of the base information is still

the same. This system would generate approximately 1,357 kilowatt hours, equating to \$77.35 of electricity at a rate of \$0.57/kilowatt hour. So what has changed?

Last year we were looking at an estimated installed cost of \$5/watt, or \$5,000, for a 1 kW system. The simple payback on this system after tax credits was 39 years. This year we are looking at \$3/watt, and a simple payback after tax credits of approximately 21 years.

When members ask questions regarding DG, I preface my answers by stating how things are today. As you can see from the example above, this industry is changing very fast. Plus, key elements such as rates, technological advancements and economies of scale all indicate that this trend will likely continue.

In light of this trend, our big concern is shifting costs from owners of a DG system to those that don't own one. Vigilante Electric does not have a rate classification specifically for members with an interconnected DG system. Currently, these services are subject to the same terms and conditions as all other services under the two residential rate schedules.

For these reasons, our board of trustees and general manager are diligently analyzing this issue. We want to remain supportive of the installation of DG on our system, while safeguarding rate structures that ensure the costs of building and maintaining our system are met, and that one group is not being subsidized by others.


This payment gateway is compliant with payment card industry guidelines, and allows us to provide a fully secure transaction from card swipe to authorization. Data is encrypted immediately upon swiping your card. Card data is never stored and all Vigilante Electric receives is notification that the payment has been accepted or denied, and the last four digits of the card to print on the receipt.

We feel that the addition of the VeriFone card terminal is a great complement to our other payment options — electronic fund transfer (EFT),

Capital Credits

There are many things that make electric cooperatives different from other electric utilities. First and foremost is that we are owned by those we serve, and while there are many unique features of an electric cooperative, there is one thing that we receive many questions about — capital credits.

Your cooperative is, by law, a nonprofit organization. After all financial commitments are met, any excess revenue is credited back to the membership. The capital credit system, which was adopted at the 1947 Annual Meeting, provides a method for allocating to each individual member their share of excess revenues, or net margins.

The term “capital credits” is used because the actual money, which is classified as net margins, is invested in cooperative capital such as reserves or equipment. This

money belongs to the members, but they have agreed to its use for capital purposes by accepting the capital credit provisions in the bylaws.

Annually, a capital credit statement is sent to members notifying them of the allocation of margins for the previous year. When financial conditions permit, a general retirement of capital can be made. The capital credits, allocated for a particular year or years, will be paid to the individual member. The current cycle for payout is approximately 18 years.

In the event of the death of a cooperative member, our main office should be contacted as soon as possible to discuss options concerning estate payments. If you have any questions regarding capital credits, please contact our Dillon office.
